BRIEFING NOTE Geographic Distribution of Social Housing in South Australia

Social housing (that is, public and community housing) is not evenly spread across South Australia. Its geographic distribution reflects both the early role of public housing in economic development strategies under the Playford government and so was focused on manufacturing industrial areas, and more recently, the neoliberal shift to public housing as a targeted welfare measure which sees a concentration on lower socio-economic areas. In practice, the two approaches often overlapped and deliver(ed) similar geographic patterns.

Data from the 2021 ABS Census of Population and Housing shows that the South Australian social housing estate is spread between Greater Adelaide and the rest of the state in broad proportion to the population share, with a slight bias towards Adelaide.

Greater Adelaide accounted for 77.9% of the South Australian population and 78.2% of all social housing. Social housing in Adelaide constituted 5.6% of all occupied housing in Adelaide, and 5.4% of all occupied housing in the rest of the state.



However, the distribution is not evenly spread within those two broad zones. As the following graph and table show, social housing is concentrated in Adelaide's north and western suburbs, and in the Eyre Peninsula and far north of the state.

Regional areas closest to Greater Adelaide have the lowest density of social housing, while the Limestone Coast and Murray-Mallee have rates of social housing just below the state average, largely due to relative fewer community housing dwellings.
